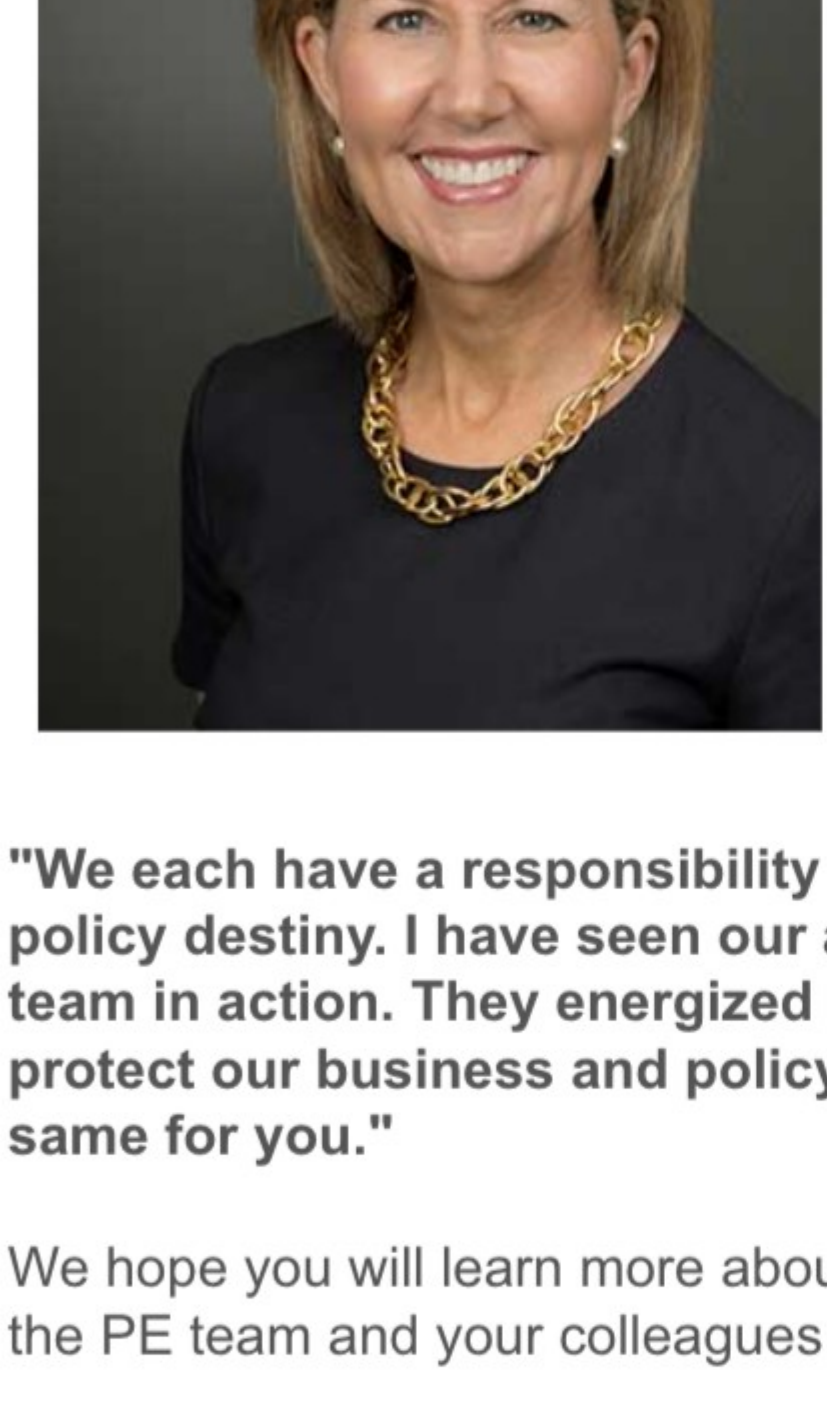

## Message from Kate Carey

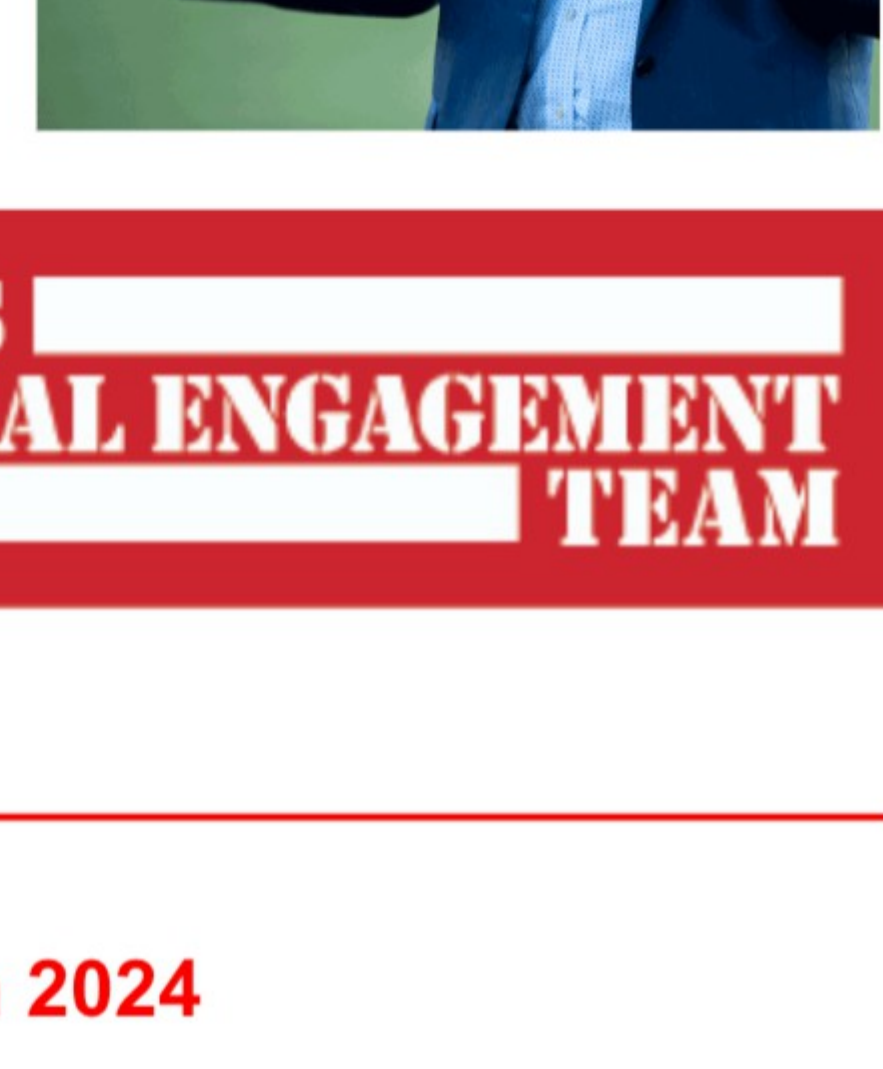

The Legislative Action Day 2024 date is confirmed! Help make the industry's voice heard by federal legislators by joining your colleagues in Washington, D.C. on **Tuesday, May 21, 2024!** We will be following a slightly different date pattern with Legislative Action Day on a Tuesday, immediately preceded by the Legal and Government Affairs Committee meeting on Monday, May 20, 2024.

The morning program will be hosted at the InterContinental Washington D.C. - The Wharf followed by meetings with members of Congress and their staff in the afternoon. Registration details will be forthcoming.

APCIA's Federal Legislative Action Day brings together property casualty insurance executives — primarily CEOs and government affairs professionals — to meet with bipartisan members of the House and Senate from across the country to discuss the issues impacting the property casualty insurance industry.

The event is an opportunity for APCIA members to speak directly with federal lawmakers who represent them in the states where they do business, and demonstrate how public policy impacts their company, the industry, and especially their policyholders, employees, and the communities they serve.

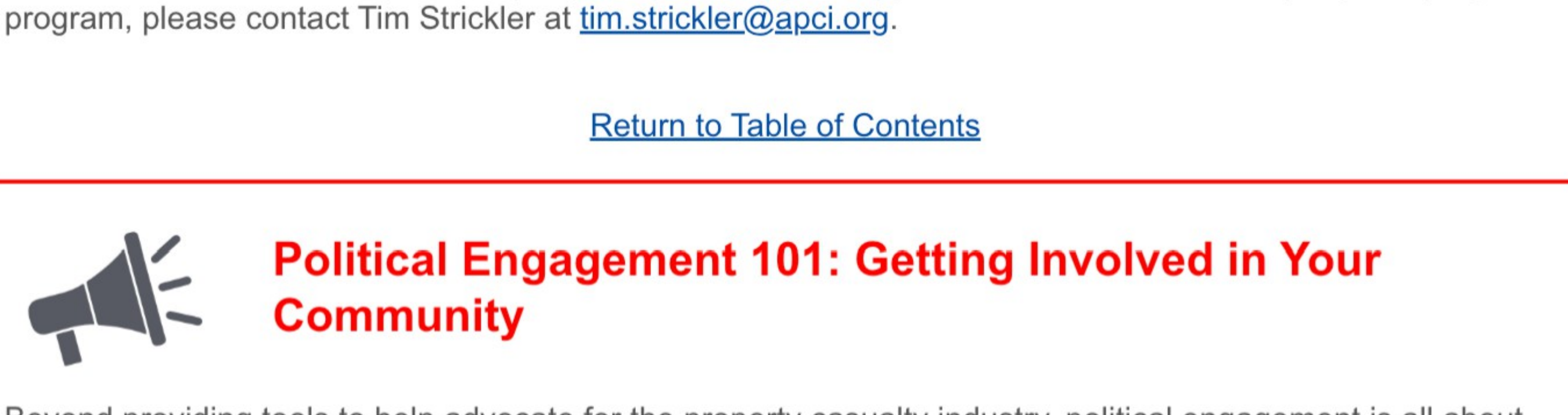

## PAC Chairman's Challenge: PAC Eligible Company Employee Participation on the Rise

### Year-to-date Company Campaign Results



Earlier this year, Insuring America PAC Chair Mike Gerik and the APCIA PAC Board of Directors set a new 2023-2024 Election Cycle fundraising goal of \$1,425,000, roughly a 6% increase from last cycle's \$1,350,000 goal. This increase was made to ensure the PAC has the resources needed to support key lawmakers on both sides of the aisle.

As of September 15, 2023, Insuring America PAC has raised \$556,705, representing 39% of the cycle goal. Through hosting Insuring America PAC company campaigns, participation among PAC eligible companies has reached new levels in 2023. As of September 15, eleven member companies have hosted a campaign this year, as well as last year. In total, these companies have raised nearly \$200,000 in PAC contributions, representing more than a 35% increase in total dollars raised and nearly a 67% increase in the total donors participating compared to 2022 totals.

The Insuring America PAC team partners closely with PAC eligible companies, providing the resources needed to host a campaign tailored specifically to fit the needs of the company, including messaging, direct mail and email communications, a communications calendar, donation reporting, and more. Here are a few opportunities to help you get started:

- Vote:** By participating in local, state, and national elections, you have a direct say in choosing leaders who shape policies that impact your community.
- Attend Town Halls:** Town hall meetings provide a platform for citizens to voice their concerns, ask questions, and engage with local officials.
- Contact Elected Representatives:** Reach out to your elected officials to express your opinions on specific policies or issues. Phone calls, emails, or letters can convey your perspective and influence the decisions they make.
- Engage in Online Advocacy:** Social media platforms offer opportunities to share information, raise awareness, and connect with others who are passionate about similar causes.
- Political Giving:** For those who are eligible, [Insuring America PAC](#) allows individuals to make a collective impact on the electoral process with voluntary, personal contributions that are pooled together to support the campaigns of candidates for office.
- Participate in Grassroots Campaigns:** Grassroots campaigns empower individuals to raise awareness and advocate for specific causes. APCIA's political engagement grassroots program, [Voice of America's Insurers](#), provides opportunities for you to participate in direct advocacy on industry priorities.

Remember, political engagement is not limited to any one method. Find the approaches that resonate with you, and do not be afraid to try new ways of getting involved. By taking these steps, you become an essential part of the democratic process and contribute to a stronger, more vibrant community.
